TRAINING COURSE AIM

This course will enable you to create Traffic Management Plans (TMPs) as well as design, select & modify Traffic Control Plans (TCPs) which are also known as Traffic Control Guidance Plans (TCGPs) & conduct inspections. To Prepare Work Zone Traffic Management Plans in NSW it is a Roads & Maritime (RMS) requirement that you hold a current Prepare Work Zone Traffic Management Plan Photo Card. The Prepare Work Zone Traffic Management Plan Photo card is valid for 3 years.

COURSE CONTENT

- Collect all required information about a given roadwork project to enable the preparation of a TCGS/TCP.
- Design, select and modify a TCGS/TCP
- Draw up a TCGS/TCP to recognise other graphical representations
- Determine the recommended spacing between signs and traffic control
- Incorporate Environmental Management Plans
- Conduct an onsite check and inspection of the plan and to identify any unexpected hazards/risks.
- Identify approvals required
- Understand speed, environment, type & class of vehicles, traffic density, sight lines, environmental condition, weather patterns surface type.
- Monitor and interpret control systems to apply to the drawing, selection and design.
- Use approved methods and follow recognised local legislation.
- Use the site/location assessment, distinguish topographical landmarks and carry out authorised risk control
- Collate traffic volume data, type and class of vehicles
- Determine lane capacity, road network performance and lane closure restrictions
- Identify impacts from any concurrent or adjacent works
- Identify times & dates of any public events that may result in increased or redistributed traffic patterns
- Identify affected stakeholders and type

UPON COMPLETION

Upon successful completion of the course, a Statement of Completion Certificate will be issued; this certificate is valid for three months. This allows the participant to gain employment and therefore be eligible for the practical assessment. If successful, a statement of attainment will be issued on the day and an RMS photo card will be issued via post.

ELIGIBILITY

As this course is held in a traffic control environment, you must wear FULL PPE which includes steel capped boots, long pants, long sleeve shirt, hat and sunscreen. Candidates are required to present photo identification upon attendance at this course.

You must have:

- A minimum 12 months demonstrated industry experience in Traffic Control
- A minimum 12 months demonstrated experience in Implementing Traffic Control Plans
- A minimum 12 months demonstrated industry experience in Road Works & Traffic Management

Or

- Previously expired Prepare Work Zone Traffic Management Plan Photo Card
